Estrella Resources Limited ('the Company') advises that it has issued 14,000,000 unlisted options to Directors and employees pursuant to the Company's Employee Share Option Plan (ESOP) as approved by shareholders on 26 April 2018. The options are exercisable at \$0.03 and expire on 20 November 2022.

The options issued includes 9,000,000 options issued to Directors which were approved by shareholders at the AGM on 19 November 2019. The Directors have also agreed to issue 5,000,000 options to employees including 2,500,000 options to the Company's CEO Chris Daws as a means of providing a performance based incentive to align gains made by key staff and management with shareholder gains above the exercise price.
